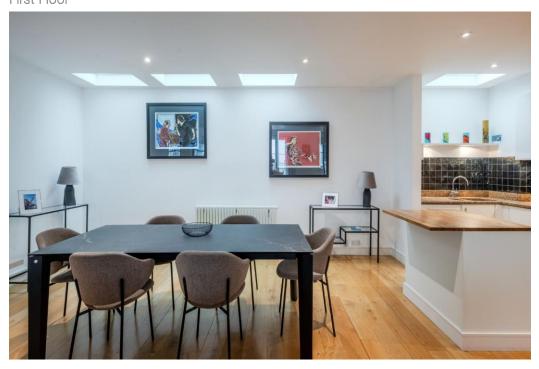

A three bedroom mews house with a large four car garage, at walking distance from Hyde Park and Kensington Gardens.

The property offers a large four car garage, accessed by two double garage doors perfect for workshop space or car collection. On the ground floor we also have a utility room and W.C. The first floor boasts a particularly large and bright open plan living and dining room, with kitchen. Natural light enters the room through the skylights at the rear and large windows at the front, including a Juliet balcony. On the second floor, we find the master bedroom with large ensuite, and two further bedrooms with separate shower room. The property also benefits from a south-facing balcony.

LOCATION

Lancaster Mews is a quiet, predominantly residential mews just to the north of Lancaster Gate and is accessed from Craven Terrace. Excellent transport facilities from Paddington with services to Heathrow and the West.
