LOCATION

The house is situated within the Pembridge Conservation and is located to the southern end of the street, just south of Chepstow Villas. Notting Hill Gate (Central, Circle and District Lines) and Bayswater (Circle and District Lines) tube stations are both a short walk away, providing fantastic links to the City and nearby Paddington. The green spaces of Kensington Gardens and Holland Park are also nearby.

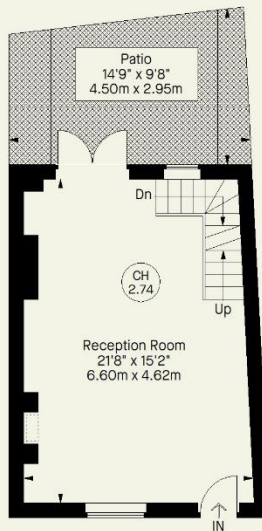
Second Floor



Third Floor

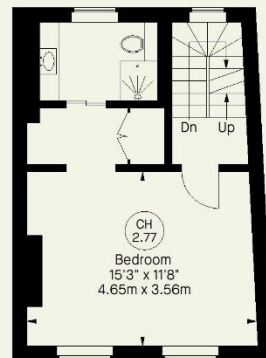


Lower Ground Floor
